AUDITORS' REPORT

Report on The Financial Statements

1. We have audited the accompanying financial statements of SSVPS's Bapusaheb Shivajirao Deore College of Engineering, Dhule which comprise the Balance-Sheet as at March 31, 2023 and Income & Expenditure Statement for the year then ended and a summary of significant accounting policies and other explanatory information, which we have signed under reference to this report.
